  - (b) That I will ensure that the tenant clears all dues and pending bills and obtain "No Dues Certificate" before vacating  
the said premise; and
  - (c) That I will be held liable to clear all dues and pending bills not cleared by the aforesaid tenant
3. That the cost for electricity connection will be agreed by the owner and the tenant in their own arrangement.
4. That the tenant will not move or remove any TANESCO infrastructure or devices installed at the aforesaid premises i.e  
pole(s), meter, wires, etc.
